Lead regulatory oversight of major changes in regulations within the Southern Cluster; communicate and coordinate with global/regional GSARA colleagues on implications and implementation of solutions for all countries included in the cluster. Ensure that strategies and activities are aligned across LATAM clusters and other regions and integrated with other parts of the business.

Engage with and build strong relationships in Regulatory Affairs Committees at key Trade Associations and with Health Authorities. Serve as a company regulatory representative in key technical and regulatory external forums.

Manage talent; prepare promising candidates for future leadership roles by expanding existing opportunities and cross-training.
